The Clerk has sent a copy of The Birbury lease to WALC who will pass it to their legal advisors for advice regarding the lease and the best action to take to protect The Birbury ad infinitum for the village.

12. Highway

12.1 Grass Verge Main Street

The Clerk advised she spoke to the officer at RBC earlier and he will arrange to survey the grass verge and supply a price to install brick setts/kerb stones within the next week.

12.2 Parking on Main Street/corner Marton Road

Warwickshire County Council Highways Department have stated the dropped kerb area was installed to allow residents to park half on the pavement/half on the road, so long as drivers park with consideration, leaving room for pushchairs/wheelchairs.

Warwickshire County Council are also looking to move the 30 m.p.h. sign and place it on the bend of Main Street/Marton Road, by the dropped kerb. Whilst obviously being a speed warning sign, it will also stop vehicles from being parked on the bend. This work is being done by WCC as a repair and there will be no charge to the Parish Council.

12.3 Traffic Survey

RESOLVED to instruct WCC to undertake a two speed surveys one on Marton Road and one on Main Street for one week at a cost of £207.00 plus vat.

13. Telephone Box

The Clerk has spoken to a company who restore telephone boxes, they cannot be done on site given the amount of work to be undertaken. The owner will send an estimate of the cost through. Clerk has established it may be possible to apply for a grant for a Heritage Grant Fund.
